## Band Concert to Honor Veterans, Benefit Memorial

A band concert will be held Tuesday, Jan. 9 at the Portland High School auditorium to raise funds for the Portland Veterans Memorial in a "welcome home" tribute to local veterans who have been serving overseas.

Dave Kuzminski, is putting together a show featuring the Portland High School Jazz Band and other celebrity headliners playing some great Rock and Roll and standards of the era.

Among the participants will be Dave's son, Sgt. David Kuzminski Jr., who is a member of the 76th Army Band and who just finished an 11-month tour in Iraq entertaining the troops. He was stationed at Camp Victory in Baghdad.

Also appearing with the group will be Spec. Raiden Rogers on guitar, who toured with David as a member of the 76th Army Band. Raiden lives in Atlanta, GA and is also home on leave. He will be making a 14-hour drive from Georgia to participate in the concert.

Both David and Raiden will be returning to Manheim, Germany after the concert. The 76th Army Band will continue to tour Europe as a goodwill ambassadors of the U.S. Army.

Dave Sr. is a longtime musician and the evening will feature a host of his talented

acquaintances as well as the Portland High School Jazz Band under the direction of Ms. Kristen Novak.

The evening will commence with Sgt. Kuzminski, a Portland High School alumnus and former member of the high school band, sitting in with the Jazz Band playing a variety of tunes to honor Portland veterans that have served in the Middle East. There are presently about two dozen veterans from town that are serving or have served in the Middle East.

The second half of the show will feature a host of celebrity musicians, including Jaimoe, who is a founding member of the legendary Allman Brothers Band and a member of the Rock & Roll Hall of Fame, as well as a platinum recording artist and Grammy award-winning musician. His career has spanned three decades and has taken him around the world.

Other notable artists will include Jeff Pitchell of Texas Flood, as well as local favorite Michael Cleary, along with bassist David Stoltz, former member of the Dicky Betts Band.

Other supporting musicians, some of which are members of the faculty at Connecticut Valley School of Music and Dance, owned and operated by Dave and Ronna Kuzminski, include: John Valerio on pi-

ano; Ed Misenti on guitar; Paisely Rameriz, saxophone; Joe Bartolotta, saxophone; Gerry Todro on keyboards; Jon Peckman, drums/percussion, as well as Dave Kuzminski Sr. on guitar and vocals. Audio engineers Sandy Imperatrice and Gabriel Field of Event Production Group will provide the sound for the evening.

Tickets to the concert are \$5 and all proceeds will go to the Portland Veterans Memorial Fund. The show will start promptly at 7 p.m. There will be a brief ceremony prior to the concert honoring Portland's veterans, as well as a meet and greet immediately following the concert, with refreshments.

Tickets are available at the Coffeepot, Connecticut Valley School of Music & Dance, Portland Discount Liquors and the Quonset Store. There will also be tickets available at the door.

The Veterans Committee has paid the first \$37,000 to finish the stones and inscribe the names on the planned monument. The veterans are trying to raise a final \$16,000 to finish the project.

## Portland Rings in the New Year with a Fresh Face

On the heels of the New Year, Stephen Kinsella was sworn in as Portland's new Judge of Probate Wednesday morning. The brief of ceremony took place in the Judge of Probate's office at Portland's Town Hall, with about 30 on-lookers squeezing into the room.

Back in November Kinsella edged out his Republican opponent Richard Carella by just 175 votes.

Originally from Hartford, Judge Kinsella moved to Portland 15 years ago with his wife Nancy. They have two sons, James and Jude.

Kinsella recently retired from his position as an attorney for the City of Hartford and was encouraged by the local Democratic party to seek out the probate judgeship.

No stranger to town government, Kinsella, will be reducing his other community commitments as a result of his election. As a result of his new post, he stepped down from his sixth term on the Board of Assessment Appeals, as well as from the Gildersleeve Educational Trust Fund. He also relinquished his position as chairman of the Democratic Town Committee in Portland.

Kinsella is currently also on the Charter Revision Committee. He says he plans to reevaluate his status there after getting a feel for the nature of the new job.

The Kinsella name is not a new one to Connecticut government. Kinsella's father, George "Pete" Kinsella, who was on hand Wednesday morning, served as Mayor of Hartford from 1965 to 1967. His uncle, James, was also active in Hartford politics.

After taking the oath, administered by Town Clerk Bernadette Dillon, the new judge expressed his thanks to supporters. "Many of you have been helpful throughout all of this," he said. "I just want you to know that that door will be open every day."

According to Kinsella, Portland's Judge of

Probate office is one of only a few in the state that have not been computerized. However, that will change on Tuesday when a new system will be installed.

"I look forward to working with Steve at Town Hall. I know he will go a good job for the citizens of the town," said First Selectwoman Susan Bransfield.

The Judge of Probate typically deals with estate issues following a citizen's death, as well as child custody disputes and situations involving mentally challenged individuals. Fees generate the position's salary and the office exists independently of the town.

Kinsella plans to be available Mondays and Wednesday through Friday from 9 a.m.-2 p.m., and Tuesdays from 2-7 p.m. He has already begun classes to ready him for his new position and will commence operations in the office one week from today.

## Daly Resigns from Hebron Finance Board With Parting Criticism

Board of Finance Vice-Chairman Matthew Daly has resigned from his position as the Town of Hebron heads into the budget season.

Often the most conservative voice on the Republican majority board, Daly cited his recent move to Glastonbury as the main reason for his departure. His resignation became effective at the December 21 Board of Selectmen meeting.

Elected in 2003 to the finance board, Daly had pledged to lower property taxes for residence. Last November he ran unsuccessfully for the 19th District State Senate seat. Daly lost to Democrat incumbent Edith Prague in a landslide.

Had he won the election, Daly said he would have remained in Hebron.

In his three years on the finance board, Daly said he is proud of the job he has done. "Initially we made important strides," he said. "We began to bring down property taxes and forced the education boards to practice sounder fiscal policy. Then we brought in two new superintendents that have followed through with that philosophy."

Daly was quick to add the "but" to the end of his statement, alluding to the fact that there were many reasons for his resignation.

"I joined with the understanding that the Republican Party, as it traditionally has been, is about practicing fiscal responsibility," he said. "That's what I wanted to be a part of. It became clear to me after first budget, our elected officials are no longer interested in doing that."

He went on to criticize the town's spending compared to its current revenue streams.

Daly said he is most proud of keeping his promise to stand up against unbridled spending. Also on his list of accomplishments are the hiring of two new superintendents with, "seemingly more common sense when developing a budget," and the creation of the

RHAM High School football team. Daly himself played high school football and credits the experience with helping to develop his character.

As parting words to his former town, Daly said that he felt taxpayers of Hebron have been overwhelmed in last ten years with fiscally irresponsibility. "Things will not change unless there is a change in philosophy and budgeting in the town. Right now there is no longer a difference between the two parties."

Daly has already moved to Glastonbury to be close to his family and said he does not plan to seek election at any level in the near future.

## East Hampton Man Charged With Attempted Murder

An East Hampton man was charged with attempted murder on Tuesday after allegedly trying to throw his live-in girlfriend out of a third story window.

Police arrested William "Rick" Scott, 37, of Chatham Apartments at 41 East High St., Unit 35.

According to police, Scott had attempted to forcibly throw his live-in girlfriend, Angelica Griffin, 32, head-first out of their third story, bedroom window. "It was also determined that Scott had assaulted Griffin repeatedly and then fled the area," said police.

Police said "independent witnesses" had seen Scott attempting to throw Griffin out the window. Some neighbors intervened and came to Griffin's aid. Scott then left the scene in a 1992 Ford Taurus.

Griffin was transported to Middlesex Hospital's Marlborough Clinic for medical treatment of the injuries she sustained in the assault.

While police were investigating at Chatham Apartments, East Hampton Police Dispatch received calls regarding an intruder attempting to break into a residence at 113 Collie Brook Road. While officers were responding to that location, the perpetrator was reported to have forcibly entered another residents at 110 Collie Brook Road and armed himself with a knife.

The perpetrator, later identified as William "Rick" Scott from the previous deistic incident, eventually coerced the residents at the house to have him the keys to their car and stole their

1996 Honda Accord, said police. He then attempted to flee once again.

East Hampton Police arrived as Scott was attempting to leave 110 Collie Brook Rd. and a pursuit began. Police said Scott was pursued for a few miles until he lost control of the Honda and spun off the road in front of 44 Middletown Avenue.

Sgt. Michael Green and Officer Timothy Dowty apprehended Scott at gunpoint as he attempted to run away on foot. East Hampton Police Officer Mark Pekar as well as Portland Police officers and Connecticut State Police who had been summoned for back-up arrived on scene and assisted with the apprehension.

It was later determined that after fleeing the Chatham Apartments, Scott had crashed the 1992 Ford Taurus into a fence in front of 69 Collie Brook Rd. Scott then fled on foot and committed the subsequent acts of forced entry, said police.

Scott was charged with the following: criminal attempt to commit murder, assault 2<sup>nd</sup> degree, robbery 1<sup>st</sup> degree, threatening, beach of peace, burglary 2<sup>nd</sup> degree, burglary 3<sup>rd</sup> degree, larceny 2<sup>nd</sup> degree, larceny 6<sup>th</sup> degree, criminal damage to landlord's property 3<sup>rd</sup> degree, criminal mischief 3<sup>rd</sup> degree, possession of drug paraphernalia, engaging in pursuit, evading responsibility and interfering with police.

Scott, who police said is a multi-convicted felon, was held in lieu of \$500,000 bond and was arraigned in Middlesex Superior Court on Wednesday.

## Stan Soby Appointed Colchester First Selectman

The Board of Selectmen voted unanimously at its last regular meeting to appoint Republican selectman Stan Soby to the position of first selectman.

The board voted to appoint Soby after First Selectman Jenny Contois formally—and emotionally—resigned her post as first selectman at the Dec. 21st Board of Selectmen's meeting. She served as first selectman for 15 years. Contois stepped down in order to accept a job as U.S. Rep. Joe Courtney's regional director.

Those in attendance at the meeting applauded and gave Contois a standing ovation in recognition of her service.

After outlining what the town charter prescribes for filling such a vacancy, Contois excused herself from deliberations, as well as the final vote. Selectmen voted 4-0 to appoint Soby.

Selectman Greg Cordova nominated Soby, who ultimately accepted the nomination and the appointment.

"Stan has proven himself time after time. His knowledge of management and budgets is a plus. I feel comfortable replacing an icon like [Contois] with Stan," said Selectman David Stollman.

Soby accepted the job, though he made his intentions clear to the public and the Board of Selectman before accepting the job.

"I have a job outside Colchester—a career, really. I have no plans of leaving my career, but this opportunity presented itself and my organization is willing to give me time," he said.

Soby works at the Connecticut Institute for the Blind in Hartford.

Soby will serve until the regular election in November. He said he has no intention of running for first selectman in November, but said he is willing to serve as a regular selectman.

Selectman John Malsbenden expressed confidence in Soby. He said it was his opinion that it would be better for the town—as well as the political process—if the position were to be filled from one of the sitting selectmen if at all possible, as opposed to holding a special election for a replacement, as the town charter reads.

Malsbenden also it clear that he has no intentions of serving as first selectman.

There was considerable speculation after Contois announced that she would be resigning to take the position with Courtney's staff that Malsbenden, a fellow Democrat, would serve as first selectman.

"Some people have suggested that I run for first selectman," remarked Malsbenden. "It's not in the cards for that long period of time. It's for 11 months. It's not going to happen. Maybe if I was 10 years younger, but I'm not. I'm 10 years older."

Soby began his term this past Thursday, Jan. 4.

Soby has served on the school board and the conservation and ethics commissions, as well as on a number of committees.

# Unusual Pet Killed by Car on Route 66 in Marlborough

One of Marlborough's more unusual residents was killed Tuesday night.

Willy, a pet wallaby owned by a Marlborough resident, was killed when a car hit the animal alongside of Route 66.

A wallaby is a member of the marsupial family. It is usually smaller and stockier than a kangaroo and native to Australia.

The accident occurred near the Hebron-Marlborough town line. The driver of the car, Ellen Jagielo, of Hebron, reported no injuries.

Marlborough First Selectman Bill Black said a local resident owned Willy. "He was a frequent visitor to the Town Hall and even some Building [Commission] meetings," he reported.

Black noted that the owner did have the proper license to raise exotic pets and added that Willy was, "very friendly," and "great with people."

State Police Trooper Mark Packer is conducting an ongoing investigation into the accident. He called the incident, "the weirdest car vs. animal call," he'd ever responded to.

Neither Black nor Packer would identify the owner of the deceased wallaby.

### Ingerlise Randlov-Marino

Ingerlise Randlov-Marino of Renee Drive, Colchester, died Friday, Dec. 29, peacefully surrounded by her loving family at Middlesex Memorial Hospital.

She was born in Esbjerg, Denmark. Her father, Laurice Riis was a prominent businessman who owned his own shoe factory. Her mother, Magda Riis, was a homemaker who lovingly took care of her home and ten children.

Ingerlise met her first husband, Axel Frederik Randlov after World War II in the Tivoli Gardens. She mistakenly thought he was an injured soldier and feeling pity introduced herself and the rest is history. Axel and Ingerlise Randlov competed together as members of the Danish Olympic Rowing Team. Looking for a better life they decided to immigrate to the USA. Axel went first to set up an apartment and Ingerlise followed three months later on Feb. 24, 1956 with two small children in tow. She was very courageous to leave all her family behind to come to a new country. She learned the language and became an American citizen in 1964.
